She wants Sampson Musah of Accra and Alberta Abanda to be the executors and trustees of her will. She gives all her personal chattels to her husband, Dr. Jeremiah Kasuwale, who is also to be her residuary legatee. Their house at Damongo in the Northern Region, now Savanna Region of the Republic of Ghana should also be given to her husband absolutely. Her sister, Mrs Adisa Iddi, is to take her house, "Safari House" at Mole.

She further directs that her church member, Cynthia Saaka is to be given GH¢500 from her Savings account held with Zenith Bank, Tamale Market Circle Branch. Her Kantanka Car No. XX 1234 P she gives to her husband. An amount of ten thousand Ghana Cedis in her current account No. X1102078271, Great African Bank, Ridge Branch, Accra should be put in trust

and shared equally among their three children, namely, Donald, John and Hillary until they each attain eighteen years of age.
