QUESTION 1

Charles Silver was the accountant of Moyoyo Company Ltd; producers of aluminum Roofing sheets, based at Apremdu Takoradi. His duties included the paying of monies received on behalf of the company into the accounts of the Company at UNIVERSAL BANK also at Takoradi.

On the 19th of January 2004, Charles Silver went to the Universal Bank to pay in the sum of ¢360,000,000 into the Company's accounts. He however struck a deal with the Receiving cashier, Raymond Nash at the Universal Bank.

By this deal, Charles Silver paid into the Bank, only \$200,000,000, but the original and triplicate copies of the Pay-In slip no 700027, which would be retained by him for accounting purposes bore the actual amount of \$360,000,000, which he was to have paid.

The duplicate copy of the Pay-In slip 700027 kept by the Bankhowever showed that only \$300,000,000 had been credited into the account of the Company. Charles Silver prepared the Pay-In slip 700027 while Ray Nash stamped all the copies with the Bank's stamp. On the 23rd of March 2004 Charles Silver again went to the Ban pay in monies collected on behalf of the Company. This time, he hav ¢790,000,000, but paid in only ¢700,000,000. He prepared pay-in slip no 700028 showing ¢790,000,000 on the original and triplicate, while the duplicate showed ¢700,000,000.Again Raymond Nash stamped all the copies of the Pay-In slips with the Bank's stamp. For his co-operation on those two occasion's Raymond Nash received a cash donation of ¢20,000,000 from Charles Silver.

On the 9th of June 2004, Charles Silver went to pay in the sum of ¢900,000,000. Again he prepared a Pay-In slip no 700087, which showed on the original and triplicate that he had paid this amount into the Company's account. But on the duplicate copy retained by the Bank, the Pay-In slip showed that only ¢800,000,000 had been credited to the Company's account. Raymond Nash received another Cash donation of ¢5,000,000 from Charles Silver

The Internal Auditor Kojo Best who could have exposed this fraud through Bank reconciliation failed to do so, because he also received a Cash donation of \$5,000,000 from Charles Silver. During an external audit in Dec.2004 the deal was detected.

When the Circuit Judge asked Kwesi Atta if he had anything to say about the facts as narrated by the Prosecutor, he replied:

" It is true Ato was seen in my room; His father came to see him in my room."

The Judge convicted and sentenced him to 5 years IH.L.
