On seeing Ofosu Ababio washing his vehicle, he thought he was a thief trying to steal from the vehicle. So he shot Ofosu Ababio dead.

Safo Addo was charged with murder by the Attorney General and was committed to stand trial at the High Court, Accra.

Describe the trial from his arraignment to the time the Jury would deliver their verdict.

- b) Draft an affidavit in support of the motion for extension of time.
- c) Draft a petition of appeal pursuant to the grant of extension of time.
