Question 1.

GLOBAL AID is an NGO based in Elmina in the Central Region. Edmund Kwao is the Head of the said NGO. Theodore Opuni is the Accountant. The Cashier is Gershon Oku. Mawusi Sewoe and Esinam Gakpo are both Field Assistants working with the NGO whose duty it is to collect data from identifiable persons in the local fishing community. The fishermen that are identified are provided with periodical financial and material support.

On 9th December, 2016 at Elmina, Percy Kubi who is a seamstress and a friend of Esinam Gakpo advised her to add fictitious names to the list being compiled

by her for the NGO in order to make extra money. Esinam Gakpo on that same day informed Mawusi Sewoe about the advice and both of them agreed to alter fifty of the actual names collected. The two on 10th December, 2016 altered the list by adding 50 (fifty) fictitious names. The total list stood at 100 (one hundred).

On 11^{th} December 2016, Esinam Gakpo informed the Cashier and the Accountant about what they had done. The Cashier and the Accountant are the two responsible for the actual payment of the monies to the beneficiaries. Each beneficiary was to be given GH¢2,000.00 (Two Thousand Ghana Cedis). The Accountant initially refused to consent to the illegal act but was encouraged by the Cashier and he finally gave in. The four agreed to take the money earmarked for the fictitious names to share among themselves.

On 12th December, 2016, the Cashier agreed with Esinam Gakpo that the services of one Ebow Sarbah, a private printer, should be engaged to forge identity cards to use in supporting the fictitious registered names. That same day the cashier contacted Ebow Sarbah and instructed him to forge 50 I.D. cards with fake pictures generated from the internet. Ebow Sarbah did exactly as instructed and cleverly inserted them on the list of the NGO. The money was disbursed to the fishermen on 14th December, 2016 and on that same day, the Cashier gave Ebow Sarbah the cash sum of GH¢2,000.00 (Two Thousand Ghana Cedis) and in addition bought him a brand new Samsung Smart Television. The remaining money was shared on that very day by the Cashier, Accountant and the two Field Assistants.

On the 14th January 2017, the two Field Assistants were tasked to inspect the outboard motor fishing machines of the fishermen to enable the NGO provide those to be identified with financial assistance to buy new ones. One beneficiary was GH¢10,000.00(Ten Thousand Ghana Cedis). The Cashier instructed Esinam Gakpo to add ten (ten) fictitious names to list of the intended beneficiaries. Esinam Gakpo agreed with her colleague Mawusi Sewoe to do as instructed and they did exactly that by adding ten (10) fictitious names, making the total list to be forty (40). The next day, the cashier agreed with the Accountant to once again forge I.D. cards to cover at ten (10) fictitious names. The Cashier accordingly invited Ebow Sarbah on the 18th January 2017 and instructed him as planned. However, while Ebow Sarbah was in the process of

forging the ID cards, he was caught in the act by the audit team of GLOBAL AID.

Proffer appropriate charges against all the culprits for prosecution before the appropriate court. The charges should **not be more than thirteen (13)** counts.
